csLegislation That We Need To Be Concerned About®

There is a proposed legislation in the UK and Europe (to become law on 1 April 2011) and the USA to make health and dietary supplements such as vitamins and minerals, as well as natural herbs, ayurvedic and other alternative medicines, illegal. It has already become law in Australia.

Even though the Vibrionics remedies don't contain any physical substance, we feel that our healers may want to express their horror and disapproval at the draconian measures of the proposed legislation to limit the freedom of people. Many natural health clinics, health shops and businesses will be closed down. This would also prevent the ability of people to keep healthy by using such products that have proven their efficacy and non-toxicity over the years, as against the undesirable side effects of most allopathic drugs.

As this legislation could spread all over the world, we feel that our practitioners have a right to know about what is happening so they can take appropriate action.

csCase Histories Using Common Combos®

1. Perforated Appendix 02733...India

A young boy, aged 16, complained of constant abdomen pain on the right side and also of gas formation for the past three months. An ultrasound report revealed an acutely inflamed appendix with perforation and a lump on the right side of his lower abdomen. The surgeon advised an immediate operation but because of poverty, his parents refused the operation. They contacted a vibrionics healer instead who gave the following: **CC4.3 Appendicitis + CC21.11 Abscess + CC3.1 Heart Tonic...6TD**

After six weeks, the abdominal lump disappeared and the pain was 75% better but he still had occasional gas. The combo was changed to: **CC4.3 Appendicitis + CC21.11 Abscess + CC4.10 Indigestion**

After another month, the pain was 90% better but the occasional gas was still continuing. For vitality, **CC12.2 Children's Tonic** was added to the above combo. A month later the patient had no pain but was still having gas, so the healer added **CC4.2 Liver and Gall Bladder Tonic** to the above.

Two months later, the gas was gone and the boy was happy and full of energy. The combos were continued for a while for the patient to maintain good health.

2. Repeated Miscarriages ^{02763...India}

This healer had a patient who had suffered four miscarriages. She was given **CC8.1 Female Tonic + CC8.2 Pregnancy** from the start of her next conception. She took the combo throughout her pregnancy and successfully delivered a healthy baby.

3. Bipolar Disorder ^{02640...India}

A psychiatrist referred one of his patients (incidentally an allopathic doctor) to this healer. The patient, a 45-year old man, was a long time sufferer of Bipolar Disorder. He had been under the psychiatrist's care for 25 years during which time the patient was given twelve different allopathic drugs. The healer gave the patient **CC15.2 Psychiatric Disturbances...TDS** and **CC15.6 Sleep Disorders** to be taken at 7 pm and at 9 pm.

After 3 months, the psychiatrist reduced two of the patient's allopathic medications, and a few months later, the rest of the allopathic medications, except one, were discontinued. The patient has been advised to take this allopathic medicine only on a 'whenever-needed' basis. The healer says the patient is now (after one year) in very good health with a new positive view to life.

4. Brain Tumour - Glaioblastoma Multiforms Grade 4 ^{02749...New Zealand}

An adult male patient aged 53 had a brain tumour that required surgery. After the surgery, the hospital's specialist physicians informed the patient's family that he had only 14 months to live. He and his family refused to give up hope and asked for this healer's help. She prescribed: **CC2.1 Cancers - All + CC2.3 Tumours + CC12.1 Adult Tonic + CC18.1 Brain & Memory Tonic...TDS** and to prevent infection, **CC9.2 Acute fever...OD** but **TDS** if infection occurred.

She also advised him to start a strict vegetarian diet with lots of fresh vegetables, fruits, juices, wheat grass, barley grass, minerals, vitamins and flaxseed oil with cottage cheese.

During the same time period, the patient was also given radiation treatment. He had no side effects during and after the treatment, except that he lost a lot of weight. The healer added **CC4.1 Digestion Tonic...TDS** and the weight returned after a few weeks. In three months time, the patient was feeling much better, however, his blood count became dangerously low due to an inherited blood disease that causes thalassaemia. His doctors advised a blood transfusion but it was avoided with just 2 doses of **CC3.1 Heart Tonic**!

Ten months after the Vibrionics treatment, the patient underwent blood tests and an MRI scan at the hospital. The results amazed the doctors who could hardly believe that such a terminal condition could be completely cured. The healer emphasized that the patient was praying daily with love and devotion to our beloved Sai Baba as were his family and the healer and the healer's family too. She says in her report, "We know that Man treats but God cures".

5. Opium Addiction and others ^{02638...Iran}

It is regretted that this healer did not give more details in the cases below: One of his patients had been addicted to opium since he was seven years old but after taking the combo for addictions **CC15.3**, he has overcome his addiction after a short time.

Another patient suffered with shoulder and neck pain for eight months but after being treated with common combo for muscles and joints **CC20.2**, she has had no pain.

Two patients had been sufferers of migraine headaches for many years. After taking **CC11.4** Migraines regularly, both were free of the excruciating migraine pain.

Note: When practitioners have cases that are of particular merit and they want those cases to be considered for publication in the newsletter as inspiration to others, it is important that each case be fully reported; giving age and gender of the patient, length of illness or condition, combos used, amount of time taken for healing and any other relevant information that would be of interest.

Garage Corner

Question: Can a vibrionics remedy be given while the patient is taking homoeopathic remedies?

Answer: Homoeopathy is compatible with healing vibrations! However, some homoeo remedies can be neutralised by certain vibrations. So to be on the safe side, don't give vibrations when the patient is taking a homoeo treatment which is working. If the homoeo treatment is not working, then the patient can stop the homoeo treatment and start taking the vibrations.

Question: Can these vibrations be prescribed to a patient who is currently on allopathic medicines?

Answer: Yes, vibrations are compatible with allopathic medicines (including chemotherapy); so, these can be taken along with the latter. However, as improvement takes place, allopathic dose should be reduced gradually. The patient may like to work with his allopathic doctor for advice on dosage reduction.

Question: What if I make an error and prescribe the wrong vibrations and what is my legal position?

Answer: As all our vibrations are healing vibrations, they are totally harmless and without any side-effects; hence they can be prescribed with confidence. When you serve with love, God protects you. You are not doing anything illegal while serving your patients with love. You are not acting in the capacity of a doctor but simply balancing the energies in the patient's body. Sugar pills can be treated as Baba's prasadam. In doubtful cases, you should label bottle "sugar pills ONLY".

Question: Can these vibrations be prescribed to a patient who is currently taking vitamins and water from algae?

Answer: Yes, vibro treatment is generally complimentary to other natural health products and dietary supplements.

Question: How long do the vibrations last in pills?

Answer: Vibrations can last for up to 3 months provided the pills are stored carefully and not exposed to direct sunlight or a strong magnetic field such as radiation from mobile phones, computers, TV etc.

Question: How important is the healer's physical and mental health at the time of prescribing? Is it OK to prescribe when we are stressed/depressed/sad? Can we prescribe if we, ourselves, are running a fever/cold or having a migraine attack?

Answer: It is good for a healer to be fit physically and mentally. When engaged in healing seva, often a healer will temporarily overcome his own depression/sadness etc. while helping a patient with his problem. Yes, it is OK to prescribe when you are not too well, provided: a. you are able to think clearly. b. before starting a healing session, you are able to pray to Swami with a clear mind, to seek His guidance and help.

Question: Is the effectiveness of a remedy decreased if we do not enter the details of the same in the Case sheet of the patient? Sometimes for a family member we prescribe say, CC9.2 for the suspected beginnings of a cold (not too serious to record immediately) OR sometimes the patient does not have time for a formal sitting OR the healer is in a hurry. Though we may enter the details later, does it matter that we do not do so at the time of dispensing the remedy? Is the case sheet only for tracking/legal reasons?

Answer: No, the effectiveness of the remedy is NOT affected. Records are not only kept for tracking purposes, they also serve as a reminder of what was given in a previous case for you to refer to in a similar case at a later date. You may not always remember exactly what was given previously so it is best to keep records. Also, it is important to remember, if the case turns out to be of particular merit and needs to be reported to us for publishing, full details are required.

Could hot cocoa be the next "wonder drug" for high blood pressure? Harvard researchers praise stunningly simple discovery!

According to recent estimates, nearly 1 in 3 American adults has high blood pressure. But for the Kuna Indians living on a group of islands off the Caribbean coast of Panama, hypertension doesn't even exist. In fact, after age 60, the average blood pressure for Kuna Indian is a perfect 110/70.

Is it because they eat less salt? No. Kuna Indians eat as much, if not more salt, than people in the US. Is it due to their genes? No. Kuna Indians who move away from the islands are just as likely to suffer from high blood pressure as anyone else! So what makes these folks practically "immune" to hypertension—and lets them enjoy much lower death rates from heart attacks, strokes, diabetes, and cancer?

Harvard researchers were stunned to discover it's because they drink about 5 cups of cocoa each day. That's right, cocoa! Studies show the flavonols in cocoa stimulate the body's production of nitric oxide boosting blood flow to your heart, brain, and other organs. In fact, one study found cocoa thins your blood just as well as low-dose aspirin!

But that's not all. A Harvard Medical School professor claims cocoa can also treat blocked arteries, congestive heart failure, stroke, dementia, even impotence! Source: Daily Health News.


