Dear Practitioners

Over the past 21 years Sai Vibrionics has made huge strides. More and more people are now seeking alternative therapies for their ailments and Vibrionics is becoming more known. Last year especially we saw a strong uptick in inquiries about Vibrionics therapy in response to information provided by individual practitioners and also in response to resources available on the Internet, including the introductory video <u>Vibrionics, Sai Ram Healing vibrations. What is it?</u>, the <u>Souljourns interviews</u>, the <u>Vibrionics website</u>, and the online <u>Newsletter</u>.

So you may also have found more people coming to you knowing something about Vibrionics.

One of the questions that often comes up is: What is the relationship of vibrionics therapy to allopathic medicine? We have always stated that vibrionics therapy is compatible with allopathic care. It is not necessary to stop medical therapy in order to take Vibrionics. Especially for serious chronic conditions like diabetes, heart disease or mental illness, no patient should ever be told to stop allopathic medicines. If a patient is under the care of a physician, the patient should consult with the physician before making any changes. This should be understood by all practitioners.

At the same time, we do believe that Vibrionics can provide good support for medical care. Also, where medical care is not available or the patient wishes to try an alternative, vibrionics therapy has been shown to be effective. Sai Vibrionics has been Divinely engineered to always benefit the patient. It can never do harm, unlike some other methods of treatment.

We are now undertaking an initiative to make this therapy more acceptable to the medical profession by collecting evidence of improvements attributable to Vibrionics. We are asking all practitioners to submit their cases where they can substantiate the improvement in their patients with medical reports eg., ultrasounds, blood test reports, X-rays etc. We hope such documentation can help convince the readers that the improvements are due to Vibrionics treatment. Testimonials from patients or their doctors will also be useful. At this moment in time we are starting this project with diabetes and serious heart ailments but in time we shall include other diseases. So, please start sending your case materials on diabetes and heart ailments to me directly at news@vibrionics.org. I will carefully consider every submission and respond to you.

I have an additional request for practitioners who are planning to present information about Vibrionics in their local communities: All practitioners who wish to give a talk about vibrionics or distribute a flyer, please check with your area coordinator and get their approval for the material first. It is essential that practitioners do not pass on exaggerated or distorted information out of enthusiasm for this therapy. Also, practitioners at the AVP level should not consider giving talks or making presentations to any groups.

Coming up next month on 24th April is the Mahasamadhi day celebration, Sri Sathya Sai Aradhana Mahotsavam. We will all observe this solemn anniversary differently. For many, it will be a time for self-reflection but also a time to put our commitment to love and service into action. I think a good way for Vibrionics practitioners to express their gratitude to Baba for this Divine Healing is to rededicate ourselves. Let us always remember to serve our patients with love in our hearts and tenderness in our speech and looks, no matter how busy we are. The power of Vibrionics is further energized through our faith and love.

™ Case Histories Using Combos **№**

1. Skin rash on hands 02806...Malaysia

A 59-year-old lady complained of rashes and itchiness on hands and soles of her feet. She had the problem for 6 months. Her fingers bothered her the most. The practitioner observed fissures and cracks where the rash was on her fingers (as shown in the photos below). Her fingertips also had blisters. For symptomatic relief, she was applying steroid cream (Betasalic) and also taking oral antihistamines in the morning (Aerius 10 mg) and at night (Atarax). She wanted to stop allopathic medication.

On 10 May 2014 the practitioner gave her:

CC12.1 Adult tonic + CC15.1 Mental & Emotional tonic + CC21.3 Skin allergies + CC21.5 Dry sores ...6 pills in 90 ml mineral water, 1 tsp every 6 hours

For local application, he also prepared **CC21.3 Skin allergies + CC21.5 Dry sores**, 3 drops each in a simple cream composed of soft and liquid paraffin (Aqua cream) to be applied **BD**.

After 3 weeks' treatment on 31 May 2014, the patient reported that the blisters on her fingertips were healing much faster than before. Previously, the blisters used to take 7 days to heal; now they healed within 2 days. The itchiness was also greatly reduced. The patient said that the cream worked wonders. She was very happy with the treatment and decided to continue. As of 5 June 2014, the original symptoms had been reduced by 90% as shown in the photos below. During her next consultation on 28 August 2014, the patient reported that her skin problem was completely gone and she asked for a refill to continue with vibrionics.

2. Myasthenia gravis 10001...India

A female assistant practitioner aged 55 suffering from Myasthenia gravis (MG) since 2001, approached the practitioner for treatment in June 2014. All the muscles in her body had been affected, but she was especially bothered by three problems: 1. She had double vision and she had trouble keeping her eyes steady; this kept her from reading more then 15 minutes at a time and never at night. 2. Her throat muscles were weak and her tongue became heavy when she was tired, which affected her ability to speak. 3. Finally her shoulders felt heavy and were easily fatigued. She also had MG-related incontinence.

In addition, she had been diagnosed with steroid-induced diabetes in 2011 and hypothyroidism in 2013. She was currently taking allopathic drugs for both problems, although her blood sugar tended to fluctuate even with the diabetes medication. Her energy level was very low.

The practitioner gave the following treatment:

For weak muscles, incontinence and vitality:

#1. CC13.3 Incontinence + CC18.4 Paralysis + CC20.4 Muscles & Supportive tissue + NM2 Blood + NM3 Bone I + NM5 Brain TS + NM7 CB7 + NM12 Combination 12 + NM17 Eye + NM21 KBS + NM45 Atomic Radiation + NM48 Vitamin Eye Compound + NM63 Back-up + NM86 Immunity + NM90 Nutrition + NM104 Tops + BR18 Circulation + BR23 Skeletal + SM14 Chemical Poison + SM26 Immunity + SR233 Ruby + SR281 Carbo Veg + SR291 Gelsemium 200C + SR360 VIBGYOR + SR374 Causticum 1M...TDS

For diabetes:

#2. CC6.3 Diabetes + CC12.4 Autoimmune diseases...BD, half an hour after lunch and dinner

For exhaustion/fatigue:

- #3. SR221 Heart Chakra + SR223 Solar Plexus...as and when needed for exhaustion
- #4. Nosode made from the allopathic medicines Wysolon, Shelcal, Glycifase, Zivast, Thyronorm, Gemohos, Folytrax, Multivitamin and Vitamin D...TDS
- #5. Blood nosode...BD, in the morning on an empty stomach and at night

After 3 months, the patient's ability to speak improved by 70% and she could now sing bhajans. Her vision also improved by 30%, so she was able to read continuously for ½ hour and even for a few minutes at night. Her blood sugar had stabilized on her previous dosage of diabetes medication. There was no change in her thyroid function or other medication. Overall she felt energetic. She specially mentioned that with remedy #3, she got instant relief from exhaustion. As of September 2014 the patient was continuing with vibro. The patient said that she was very happy with the vibro treatment as there is no cure for MG in allopathy.

If using the 108CC box give: CC7.1 Eye tonic + CC7.5 Glaucoma + CC12.2 Child tonic + CC12.4 Autoimmune diseases + CC13.3 Incontinence + CC19.7 Throat chronic + CC20.4 Muscles & Supportive tissue

3. Gangrene, Scar Tissue 01616...Croatia

An experienced practitioner aged 59 consulted a senior Practitioner ^{02793...USA} for herself on a case of gangrene. She had been bitten by a dog in October 2014. Her right hand was mangled and the little finger was badly injured. Osteomyelitis developed in the finger bone and gangrene spread in the hand. The infection did not respond to antibiotics. After a month's treatment, doctors recommended that the finger be amputated to allow the infection in the rest of the hand to be treated. The case was then taken over by another doctor at the same hospital, who was a friend of the patient. She asked him to try to save the finger, which he did. In an operation to fix the bone and clean it (22 November 2014), he also took a bone sample, which showed Staphylococcus aureus still present.

At the time, she was taking:

#1. CC20.6 Osteoporosis + NM36 War + OM3 Bone Irregularity + SM28 Injury + SR315 Staphysagria...6TD

She was also planning to add a nosode of the antibiotic. She was advised to consult our Head of Research 00002...UK and she started the following treatment on her recommendation:

#2. CC20.2 SMJ pain + CC20.3 + CC20.4 Muscles & Supportive tissue + CC20.6 Osteoporosis + CC20.7 Fractures + CC21.11 Wounds & Abrasions + NM36 War...6 pills in ½ litre of water, sip hourly during the day for 2 days, then 6TD reducing on improvement

- #3. Antibiotic nosode...TDS, to be taken separately in between the above combo
- #4. Blood nosode...BD, to be taken separately morning on waking and night before sleep

After 5 weeks, the infection was completely gone. The finger was saved, and the practitioner began physical therapy to restore hand function. The hand had immobilized for 3 months, and the joints were frozen because of adhesions and scar tissue. So she started:

#5. CC21.1 Skin tonic + NM96 Scar Tissue + NM113 Inflammation...6TD

As of March 2015, she had recovered 70% movement in her hand and finger.

The patient/practitioner's comment:

The doctors were confused by my recovery. They told me that I had a very bad outlook and that amputation had been highly probable. Thanks to the two practitioners but most of all, I would like to thank Swami for his Grace. I am enormously thankful and happy to be part of Vibrionics team. Since 1999, I have seen many good things happen for my patients through sharing Vibro.

The case lasted a long time but here's what I think about it. For 15 full years, I have been a practitioner and I have often wondered about the impatience of patients who feel that if the treatment does not work right away, then it's not right. I assure them that they need to be persistent and together we will look for combinations that will work for their situation. And so this came to be a time of temptation for me personally. Despite a situation that was deteriorating rapidly, I firmly believe in what I do, and persevered in that faith through the days and months. I always knew and I know now that Swami is with me and that He is my sole refuge.

4. Paradentosis 01619...Serbia

A woman aged 45 years developed symptoms of paradentosis in her lower jaw on 5 June 2014. She had strong inflammation, her teeth became wobbly, and her gums were red and painful. The acute symptoms had been going on for 20 days before the patient visited the dentist and he recommended tooth extraction. However, the patient decided to take vibrionics treatment.



She was given:

NM89 Mouth & Gum + NM113 Inflammation + SR293 Gunpowder...TDS.

She took no other treatment and within 15 days all symptoms disappeared completely.

With the situation normalized, vibro was continued for 3 months. The patient's gums were strengthened and she did not lose a single tooth.

The patient's comment:

In June 2014 I was suffering from paradentosis. My doctor recommended tooth extraction. After vibrionics medicine, the condition has changed and there was no need for extraction of teeth. Since then I have no problems related to paradentosis.

If using the 108CC box give: CC11.5 Mouth infections + CC11.6 Tooth infections

5. Gastritis 02897...UK

The practitioner writes: A female patient, aged 79, complained of fever, nausea, burning tongue, stomach pain and intermittent burning in the stomach. She could hardly eat because of the nausea and she was unable to take any spicy and hot food whatsoever. Food tasted very odd to her. Whenever she ate something even slightly sweet, it tasted bitter although she couldn't taste a majority of the foods. The patient also suffered from diabetes, high blood pressure and angina, for which she took allopathic medicines without any problems.

The first acute symptoms had appeared 5 weeks previous and had gradually worsened. She felt weak but blood tests showed that everything was normal and she was not anaemic. The doctor prescribed a one-week course of antibiotics. After completing the medication, she felt worse and her condition deteriorated. By the time I was approached, the patient had suffered intensely for three weeks and was completely bedridden.

I began treating the patient on 19th August 2014. From the information the patient gave to me, I felt she was suffering from gastritis and possibly malaria. She said she had travelled to the USA several months earlier and neither the doctor had tested her for this, nor had the family considered this. I prepared: CC4.1 Digestive tonic + CC4.2 Liver & Gallbladder tonic + CC4.3 Appendicitis + CC4.4 Constipation + CC4.8 Gastroenteritis + CC4.10 Indigestion + CC9.2 Infections acute + CC9.3 Tropical diseases + CC10.1 Emergencies + CC12.1 Adult tonic + CC15.1 Mental & Emotional tonic

The patient was asked to mix a few pills in 500 ml water and sip the water as follows:

Days 1-3: once every 10 minutes

Day 4: once every hour

Day 5: once every two hours

Day 6 and onwards: QDS until she begins to feel better, then reduce to TDS

After recovering: OD for 2 weeks.

By **Day 3**, patient was 45% better. She was up and about, able to make food for herself although eating was still minimal. Fever, nausea, stomach pains and burning sensation in the stomach had disappeared. By **Day 6**, the patient was 100% better and was cooking for herself and her husband, and doing regular

household chores. She felt she was back to normal. Accordingly, the patient was asked to continue the remedy TDS from **Day 7** (25th August 2014) and then after a week to reduce to **OD** for two weeks. On 14th September 2014 she stopped taking the remedy completely.

The patient recovered completely from the acute condition. She was very surprised with such a quick recovery and because of this, her faith in Sai Vibrionics has increased. She was very grateful for this remedy.

6. Gustatory rhinitis 02870...USA

An 82-year old male, a medical doctor by profession, and who happens to be practitioner's father, had gustatory rhinitis for the past 10 years. His nose would start to run as soon as he started eating -- especially when he ate hot and spicy food during lunch and dinner. His nose would run so continuously and profusely that the nasal secretions would drip onto the food and he would have to keep wiping off the secretions with a tissue while eating. The patient had consulted his medical colleagues including gastroenterologists on how to deal with this condition. More than a year ago (in the early part of 2013), he was prescribed the antihistamine Desloratadine 5 mg (1 tablet at night after dinner). He reported that the antihistamines only improved his condition by 25% and his nose continued to run during meals.

On 18 February 2014, he was given the following: CC19.1 Chest tonic + CC19.2 Respiratory allergies...TDS

Although he was given the remedies in February, he admitted he rarely took them as he was sceptical as to whether it would work and decided to give it a try at the end of April 2014. Within a week of taking the remedy on a regular basis (he reported he took it about twice a day), he observed that his nose leaked much less when eating. On 1 May, he reported that for the first time during and after meals, his nose did not leak at all. He reported that by 29 May, he saw a consistent, steady and stable improvement in his condition, with 90% reduction in nasal secretions. By June 2014, the nasal secretions completely ceased and continued to stay that way for all of July and August. But unfortunately after August, the patient did not continue taking Vibrionics despite repeated requests and reminders from the practitioner. The 100 % improvement (i.e., absolutely no nasal secretions) continued for an entire month (all of September 2014) after he had stopped taking the remedies. Then his nose gradually started leaking again in October 2014 and to date (16 March 2015) his condition is almost as bad as it was when he was first given Vibrionics.

The practitioner's comment:

This case speaks powerfully to the need for taking Vibrionics remedies regularly in a disciplined way.

[Editor: It is important that the dosage of a vibrionics remedy should follow a carefully-designed reduction procedure.]

7. Claustrophobia 02806...Malaysia

A gentleman aged 74 had been suffering from claustrophobia for 7 years. When he was in closed spaces, for example, lifts, small toilets on airplanes, and other tight space, he would panic. He would need to escape and run to an open space. He had seen a psychologist and then as a last resort, a hypnotist.

On 18 February 2014, the patient was given:

CC15.2 Psychiatric disorders...TDS

During a return visit on 3 March, the patient reported that he had recovered completely after taking the treatment for just 3 days. He was now back to his normal self.

8. Breast cancer metastasized 10014...India

A 61-year-old woman in the terminal stage of breast cancer was referred to the practitioner by a Sai devotee in July 2009. The cancer had spread from patient's right breast to nodes all over her chest and abdominal wall. It had formed a mass in her pancreas, involved her gallbladder and other digestive organs, and it had metastasized extensively throughout the soft tissues and the bones of her body. She was suffering from pain, indigestion and weakness and was almost bedridden. On 30th July, she was given:

#1. CC2.1 Cancers – all + CC4.1. Digestion tonic + CC4.2 Liver & Gallbladder tonic + CC12.1 Adult tonic + SM1 Divine Protection...6TD for 15 days, then QDS for 15 days.

She was also advised to take Ayurvedic medicine, which she started a month after taking the above combo.

As there was not much improvement, upon consultation with a Senior Practitioner ^{02709...India}, the patient's remedy was changed on 26th August to:

#2. CC2.1 Cancers - all + CC2.3 Tumours & Growths + CC4.7 Gallstones + CC4.11 Liver & Spleen...QDS

After 4 weeks (22 September), the patient showed very good improvement. She started moving about. Her husband reported that she was eating better. Her remedy was adjusted to:

#3. CC2.1 Cancers – all + CC2.3 Tumours & Growths + CC4.1. Digestion tonic + CC4.2 Liver & Gallbladder + CC4.7 Gallstones + CC4.11 Liver & Spleen...QDS

On 17 November, the husband reported that the patient's condition was very good. She was well enough to start travelling again and she went on a pilgrimage tour. She was given the following remedy to take for one month:

#4. CC2.1 Cancers – all + CC2.3 Tumours & Growths + CC4.1. Digestion tonic + CC4.2 Liver & Gallbladder + CC15.1 Mental & Emotional tonic...QDS.

After this, the patient reported she was feeling much better. The practitioner repeatedly encouraged the family to continue the remedy but as she was better they didn't return. Approximately 6-8 months later the patient passed away peacefully.

9. Neck wounds on a dog 02885...Argentina

The practitioner writes: Our dog Pitty was attacked by two dogs at my nephew's farm. He had large gaping wounds on his neck. My nephew was away at the time, so the dog went unattended for four days. My nephew's mom cleaned the wound and gave him some medicine. When my nephew returned to the farm, he brought Pitty to town to see the vet. The vet had to clean out everything and also remove all the necrotic flesh. The photos below show the wounds immediately afterwards.







When I saw Pitty on 7th May, I began vibro treatment. I gave him what I had at hand in the emergency combo kit I always carry. I chose Emergency, Be Well. Fit Well, Get Well, and Move Well.

CC9.2 Fevers & Infections + CC10.1 Emergencies + CC12.1 Adult tonic + CC15.1 Mental & emotional tonic + CC18.1 Brain disabilities + CC20.3 Arthritis + CC20.4 Muscles & Supportive tissue + CC20.5

Spine...4 pills in 1 litre water, BD for 1 month, then reduce to OD

I also put silver water (water with colloidal silver) in the left part of the wound that had an infection, because the vet did not want to clean the wound as there was too much infected tissue to take out. We put vibhuti all over the neck wounds daily and applied other modes of energy healing. After 7 days' treatment, the infection was completely gone (see photo below, left).



As of 5th June, Pitty was eating well, had regained 3 kilos and was drinking 1 litre a day of vibro water. The wound on the left had closed and the larger wound was now 10 cm x 5cm and ready to be sewn up by the vet (see photo below, right).

Practitioner Profile 10014...India

I am from Santacruz, Mumbai. I am a graduate in Mechanical Engineering and have been working for Air India for the past 22 years as an Aviation Engineer. I was introduced to vibrionics in 2007. Around the first quarter of that year I was having problems with hyperacidity and anxiety, which affected my lifestyle. I had been taking allopathic treatment for more than six months and had an endoscopy, which showed erosion of the gastro-intestinal lining. I wanted to reduce or stop allopathic medicines to avoid the side-effects of prolonged use.

In April 2007 while in Dharmkshetra, I happened to meet a Sai devotee who had the same problem and had got relief with vibrionics


treatment, He introduced me to a practitioner who is also an allopathic doctor. She was running her vibro clinic at the Sai Medical Centre in Dharmakshetra. As I took treatment from her and benefited from the

remedy, I was happy with vibrionics.

On 13 July, I was again at Dharmakshetra when a practitioner invited me to attend the Vibrionics workshop to be held during the next two days and also help him with arrangements. And thus on the evening of 15th July I started the beautiful seva of vibrational healing, with the first patient being myself. I started the treatment of my acidity with **CC4.10** Indigestion...**TDS.**

That night I placed my vibro kit along with the 108 Common Combos handbook in front of Swami's photo for a blessing. Within two days, "Aum" in vibhuti appeared on the first page of the book (see photo below, left. The image in this photo is faint.). Was this not His approval to go ahead?






Ever since I have been involved in making lists of healers, sending them official circulars, collecting and compiling reports, and also making arrangement at Dharmakshetra for conducting vibro workshops etc. as a coordinator. Swami has blessed me with this seva to date.

I completed my next level of training as JVP in December 2007. When I placed my new 108CC box before Swami's picture for a blessing, Swami's divine signature appeared on two remedy bottles and vibhuti covered the entire box. The words "With love Baba" appeared on the bottle for remedy NM18 General Fever (Bottle 25) and "Sri Sathya Sai" appeared on the bottle for remedy NM20 Injury (Bottle 29) (see photo above, right) The bottles had been prepared for

ease of dispensing at Health Camps. (I put tape over the writing to protect it after alcohol dripped on it)

After completion of my SVP course on 20 July 2013, I received the SRHVP from Dr Aggarwal and due to



Swami's grace, that evening the machine was offered for blessing at the Samadhi after Aarti.

On reaching home, I presented my SRHVP to Swami's photo for His blessing. After three days He blessed it by filling both the wells with vibhuti. I removed the vibhuti and stored it in two containers, to be used for patients having abnormal problems along with vibro pills. The taste and colour of the vibhuti in Sample well were different from that of the Remedy well. Swami also left his loving signature on the back of the last card **SR576 Tumours** (see photo).

This all happened according to Divine timing. I was blessed to have Swami's first darshan on 12th March 1999 at Dharmakshetra when Swami Inaugurated the Sai Medical Centre opposite Shanti Deep, and after exactly 9 years (in 2008) I was involved in distributing vibro pills as His blessing to patients at the same place, the Centre where I had received my first blessing from Swami.

Now I am providing vibro remedies to patients not only in my home but also in free medical camps on weekends at Shri Shirdi Sai Mandir, Kadamwadi, Kalina, Santacruz (East), Mumbai. To date I have treated over 2480 patients.

I am a kindergarten teacher and a faithful devotee of Bhagawan Sri Sathya Sai Baba. I have made a pilgrimage to Swami's ashram every year since 2010. In that year, I went to Swami's ashram with a friend, whose 7-year-old son was very ill. He was born with an enlarged heart (cardiomegaly). We went there to give the child to our Lord and we learned about Sai Vibrionics there. Dr Jit Aggarwal and Mrs Hema Aggarwal prepared the combos for the child and he started to taking Vibrionics there in India. He improves everyday. That is why I wanted to become a Sai Vibrionics practitioner. It took me two years of asking Dr Aggarwal for permission until he said yes. He trained me in the ashram. I have been a JVP since 2013 and have treated nearly 700

patients up to now all over Argentina. Swami has given me strength and enough faith to do my work with love. I love to prepare combos for children and animals. They are able to show progress very easily without inhibitions from the mind. I feel that I am blessed.

When I treat my patients, I always tell them to have FAITH that God is inside their heart.

One thing that I have found helpful in my own practice is to love what I do. When I am working with Vibrionics, I am working with Swami, pure love.

As a result of practicing Vibrionics, I feel I have changed my view of listening to my patients. I am openhearted. I have learned to listen, to give a hug, to give unconditional love, and to pray a lot.

Cases to share:

• Neck wounds on a dog

CS The Answer Corner **20**

1. **Question**: Some of my patients find that it is more convenient to prepare the vibro in water and then sip the charged water during the day. If the dosage is, say 6TD but the patient sips the water more often, is this a problem? Will this make a pull-out more likely?

Answer: A remedy taken with discipline at the prescribed dosage works best. Sometimes, the pullout maybe stronger when it is taken more often but not always. If the symptoms are highly acute, remedy can be taken frequently but it works better when it is taken with regularity. Further, remedies are always more effective when taken in water than in pills.

2. **Question:** Some practitioners add the CC combos to the bottle first and then fill the bottle with pills before shaking it. Other practitioners fill the bottle with pills first and then put the combos on top before shaking it. Are both methods correct?

Answer: Yes, the end result is the same in both cases. However, if you add the CC combos first and then add the pills, if you happen to fill the bottle more than 2/3 full, you will have to remove the extra pills, which is a waste. Also, during travel and in camps, it is more convenient to first fill the bottles with pills to carry them with you.

3. **Question:** Can vibrionics be used to treat primary sclerosing cholangitis — PSC? If so, how?

Answer: Certainly, use this combo: CC4.2 Liver & Gallbladder tonic + CC4.6 Diarrhoea + CC4.11 Liver & Spleen + CC12.4 Autoimmune diseases + 21.4 Stings & Bites.

For users of SRHVP: NM2 Blood + NM22 Liver + NM102 Skin ltch + NM113 Inflammation + BR12 Liver + SM5 Peace & Love Alignment + SR284 Chelidonium 30C + SR340 Aloe 30C + SR504 Liver.

4. **Question:** Would you please discuss the appropriate vibrionics treatment for a patient who has had transplant surgery for say the kidney, liver or heart. Is it safe to include an Immunity booster, keeping in mind that such a patient will be taking allopathic drugs to suppress the immune system in order to prevent organ rejection?

Answer: The practitioner should approach the patient not only with compassion but also with discretion and understanding while giving remedies to support the patient's allopathic treatment and at the same time, to counter any side-effects. The Vibrionics remedy should be so chosen as to help the body, mind and the whole being to remain strong, stable and at the same time accept the transplanted organ harmoniously.

Keeping the immune system from attacking the transplanted organ also requires constant vigilance, including healthy diet, appropriate exercises/yoga in consultation with the concerned doctor, and an appropriate lifestyle based on spirituality, meditation and prayers. 
It is perfectly safe to give an immunity remedy such as CC12.1 Adult tonic and in any case, give CC15.1 Mental & Emotional tonic. Of course, we should include a balance remedy/combo for the transplanted organ and a nosode of the allopathic drugs being taken by the patient.

5. **Question:** Can we give vibro remedies to people who chew paan/betel leaves and to those who drink alcohol, not necessarily too much, but on a regular basis?

Answer: Yes, vibro remedies given to such patients will be effective but we don't recommend chewing of betel leaves or drinking of alcohol. However, in order to treat an addiction to betel leaves, alcohol, tobacco or drugs, you should ensure that the patient visits you personally for treatment. At this time, it is best to ensure that the patient voluntarily confirms that he has decided to kick the habit; under such circumstances, the remedy will work at its best.

6. **Question:** Sometimes, a patient's symptoms improve initially with vibro and then reach a plateau, after which there seems to be no further improvement. What can the practitioner do to help the patient to keep improving?

Answer: Check whether the patient has taken the appropriate dosage and followed the precautions related to storing and taking the remedy. Try to establish that there is no subconscious resistance to regaining health or loss of faith in vibrionics treatment. Consider a different combination of the remedy, in addition to providing some counselling. It could be that the patient needs a systemic treatment of cleansing, applicable tonics or immunity building, perhaps one after the other over a period of time, to tone up the entire system and make it more receptive to continued improvement.

Report on Leicester Camp, 1st Feb 2015 02897...UK



For UK practitioners, this was our first camp in Leicester, with possibly another one in the pipeline still to come this year. It was a cold day and the people started to arrive by 1.00pm for a 1.30pm start. Plenty of volunteers came from Leicester to help set up for the camp. They were mainly from the local Sai Centre and this was part of their seva project under the guidance of the then centre Service Co-ordinator.

We were six practitioners in total and before we began the event, we all recited the prayer from the 108 Combo book and asked Swami to bless this event and guide us every step of the way.







Although the start was delayed by around 20 minutes, once the introduction began with the video showing, the audience's attention was fully captured. After the video, Practitioner ^{02802...UK,} who is also an allopathic doctor, enlightened the audience with her brilliant explanation of how Vibrionics works and how negativity affects us in the first place. She then demonstrated the use of Kinesiology technique with someone from the audience. She explained how effective Vibrionics is and how it affects the body in a very positive way. Once the consultations were underway after the initial introduction, they began to flow very easily and calmly. All the consultations took place on the






first floor and therefore the waiting area was kept downstairs with refreshments. This way the noise level was also kept to a minimum.
